

PEREGRINE PINES FAMCAMP TERMS AND CONDITIONS

2019-2020

1. Check in time, no earlier than 12:00 PM, Check out time, no later than 11:00AM
2. Office hours: 9 AM to 6 PM, Sun thru Thurs-9 AM to 8 PM Fri and Sat.
3. **Campers MUST** use a water pressure regulator attached to faucet end of hose due to very high water pressure.
4. All sewer connections must be sealed.
5. Limit of 2 vehicles & 1 tent per RV site, not to exceed 8 total persons. No boats or utility trailers at sites. Please park on gravel at your site or in designated areas. **Do not park on natural unimproved areas.**
6. **NO BURNING OF WOOD in FC charcoal grills. Charcoal/Propane grills permitted. Personal fire bowls may be used but must be approved by Famcamp staff. Rental fire bowls and wood are available at front office.**
(Subject to base fire regulations) X_____
7. Clothes lines are not permitted.
8. No smoking in laundry or restrooms. Please dispose of cigarette butts in a proper manner. (Do not throw on the ground)
9. Sponsors are responsible for the safe and proper conduct of their dependents and guests.

10. Designated quiet hours are 10:00 PM until 7:00 AM. X_____

11. Please **slow down**, if you see dust behind you you're speeding! **Obey the posted speed limits, 4.5 MPH**
12. Please be considerate of others. Do not cut thru other campsites.
13. Please make the Famcamp staff aware of any problems or **concerns. If after office hours call Security forces.**

14. **No washing RV'S in camp sites.** A wash site may be available. Please check with office staff on availability.
15. Please keep sites orderly and minimize clutter. All trash must be put in dumpster immediately. Police sites daily during your stay. Do not litter or feed the local wildlife.

16. NO BIRD OR ANIMAL FEEDERS PERMITTED. WE HAVE BEARS THAT LIKE THEM ALSO. X_____

17. **Children 12 and under** must be accompanied by an adult at all times, **no exceptions. Helmets must be worn when riding bikes on USAFA.**
18. Please advise office staff of intentions to extend ASAP to avoid having to move to alternate site to accommodate extension if under the 30 day maximum rule. (If have stayed 30 days, when asking for extension you may have to move if granted)

ATTENTION: The USAFA Famcamp is located near train tracks. Please be aware that there is no control of the train whistles at crossings. This is a requirement for the train operator's due to wildlife on the Academy.

PETS: (Strictly monitored)

Please be aware that the Famcamp is located in a wildlife setting. Not only does the staff as well as yourself like pets. The local predators like them also. Please keep our guest and your pets safe. Violations will be logged. Repeat offenders will be asked to leave. Barking must be kept to a minimum or you will be asked to leave.

- A. Must be on a leash or in a pen and ACCOMPANIED at all times when outdoors, NO EXCEPTIONS. Visual accompaniment from inside RV is not permitted.**
- B. Must never be left unattended in or around vehicles even for brief periods, no exceptions.**
- C. Must be picked up after immediately. Doggie litter bags located by dumpsters as a courtesy.**
- D. Not allowed in laundry/restrooms or office.**
- E. Must be registered at Vet clinic (719-333-4055) if stay exceeds 2 weeks.** X_____
