I understand that while the Outdoor Adventure Program strives to provide a safe and enjoyable experience, participating in outdoor activities can be dangerous. Such activities pose a risk of emotional or physical injury, including the possibility of serious bodily injury or death. I also understand that damage to property may occur incident to my participation in this activity.

In consideration of my application, and permitting me to participate in this event; I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release, and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter accrue as a result of my participation in or travel to and from this event; THE FOLLOWING ENTITIES OR PERSONS: The United States Air Force, the United States Air Force Academy, and the Outdoor Adventure Program to include their directors, officers, employees, volunteers, representatives, and agents, the event holders, event sponsors, event directors, and event volunteers (hereinafter collectively referred to as "OAP"); and (B) Indemnify and Hold Harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made by other individuals or entities as a result of any of my participation in, and travel to and from, this event.

_____ I understand that each activity I am about to participate in poses unique risks inherent to each activity. I understand the nature of the activities I will participate in and the associated risks. I voluntarily accept these risks along with any and all similar risks.

_____ I understand that the proper use and wear of safety equipment can greatly reduce the risk of injury. I agree to wear and/or use appropriate safety equipment as directed by law or the OAP staff.

_____ I understand that this activity may be physically strenuous and requires a certain level of physical fitness. I am in good physical condition, can meet the rigors of this event, and have not been advised otherwise by a physician. I assume the risks of any medical conditions I may have.

_____ I agree to use all provided equipment and supplies as intended and instructed. I also understand that I may be held responsible for the repair or replacement of any equipment, supplies, or facilities that are lost or damaged as a result of my participation in this event.

_____ I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in this event, or agree to bear such costs myself.

_____ I understand I may come into contact with known and unknown diseases or illnesses while participating in this activity. I agree to hold harmless the aforementioned entities in this document, and follow any safety measures required by the OAP, local, state, or federal government to limit contact with and the spread of these diseases or illnesses during my participation in this activity.
